The grievance procedure is a machinery to sort out the issues between the students and the College. It means that if a student believes that, he/she has been treated unfairly with respect to his/her academic/administrative affairs or is convinced to be discriminated is to be redressed surely. It is a device to search out the solutions of a problem. It enables to express feelings by initiating and pursuing the grievance procedure in accordance with the rules and regulations of the college. It involves a process of investigation in which Students' Grievance Cell, enquires and analyses the nature and pattern of the grievances in a strictly confidential manner. Matters are disclosed to only those who have a legitimate role in resolving the matter. The students are ought to lodge their grievances in the written form and to be submitted in the drop box placed in the college main gate. The secretary in turn intimates the matter to the committee for necessary action.

Grievances received are forwarded to the Principal for immediate redressal.

Exclusions: Some precautions to be maintained in regard to the issues which shall not be entertained, are as follows:-

- Decisions of the competent authority on assessment and examination result.
- Decision made by college under the disciplinary rules and misconduct.
- Decisions with regard to a word of scholarship seen on session awards and medals.
- Decisions of the academic committees constituted by the college.
- Decisions of the college in admission procedures of choice based courses.
